









**5.4.1 The Alumni Association/Chapters (registered and functional) contributes significantly to the development of the institution through financial and other support services.**


Resolution No. 1/2016

- (d) An individual can become a life member with the approval of governing body and subsequent ratification by general body after paying life membership fee of Rs. /-





### 5. RE-ADMISSION OF THE MEMBER:-
