

CHAPTER-2

A. Code of Pharmacy Ethics

3.1 Declaration:

Each applicant, at the time of making an application for registration under the provisions of the Act, shall be provided a copy of the declaration as specified in **Appendix I** alongwith copies of Code of Pharmaceutical Ethics and Pharmacist's oath by the state pharmacy council, who shall submit it duly signed.

3.2 Privileges of persons registered as a pharmacist on the register of State Pharmacy Council:

Subject to the conditions and restrictions laid down in these Regulations regarding practice of profession of pharmacy by persons possessing approved pharmacy qualifications, every person whose name is for the time being entered in the register of the state in which he is for the time being residing or carrying on his profession or business of pharmacy shall be entitled to practice as "Registered Pharmacist" and engage in the practice of profession of pharmacy and to receive in the course of law in respect of such practice of pharmacy any expenses, charges or any fee to which he/she is entitled in lieu of higher discharging duties as defined by the PCI from time to time.

3.3 Displaying name of owner and registered pharmacist:

(a) Name of the owner of pharmacy business shall be displayed at or near the main entrance of each premises in which the business is carried on.

(b) Name of the registered pharmacist along with his registration number and qualification along with his/her photograph shall be displayed adjacent to the area where dispensing is carried on in the pharmacy. Registered pharmacist shall also comply with a dress code of being dressed formally and wearing clean white overall (vest)apron with a badge displaying the name and registration number.
