





MEMORANDUM OF UNDERSTANDING

AND

LAUREATE INSTITUTE OF PHARMACY

THIS MEMORANDUM OF UNDERSTANDING is made this

BETWEEN

UNIVERSITI SULTAN ZAINAL ABIDIN (hereinafter referred to as "**UniSZA**"), a public university established under the Universities and University Colleges Act 1971 [Act 30] whose address is at Kampus Gong Badak, 21300 Kuala Nerus, Terengganu Darul Iman, Malaysia and shall include its lawful representatives and permitted assigns;

AND

Laureate Institute of Pharmacy (hereinafter referred to as "**LIPh**"), an institute whose address is at Kathog, Jwalamukhi, Himachal Pradesh, India and shall include its lawful representatives and permitted assigns.

UniSZA and LIPh hereinafter referred to individually as "**the Party**" and collectively as "**the Parties**".

WHEREAS

- A. UniSZA is an established public university which strives to enhance and strengthen its commitment to producing global leaders of tomorrow, and has taken various initiatives to complement its educational excellences. UniSZA has entered into various collaborative arrangements with other parties to enhance quality education and research.
- B. LIPh was established in 2007 with the vision of providing quality education in the field of Pharmacy Profession and is running under Laureate Education Society Shimla (Established in the year 1992). The ISO Certified and Internationally Accredited Institute is approved by PCI, AICTE and is affiliated to Himachal Pradesh Technical University, Hamirpur recognized under 2(f) of UGC Act.

LPIh laboratories are well equipped along with Sophisticated Instrumentation to nurture scholars of Ph.D., M. Pharm Pharmacology, and B. Pharmacy Practice scholars.

To facilitate the research and community service that is aligned with our best practice like daily health Check up camp for community and constant monitoring.

- C. The Parties are desirous of entering into this Memorandum of Understanding to declare their respective intentions and to establish a basis of co-operation and collaboration between the Parties on the terms as contained herein.

ARTICLE I

OBJECTIVE

ARTICLE II

 - (a) Organizing public lectures, scientific seminars, workshops, exhibitions, and other scientific and professional activities;
 - (b) Facilitating students of the Parties in research, internship, practical work, in accordance with available opportunities and capacities; joint research, internship for pharmacy practice and pharmacology scholars (students exchange programs) in the school of basic medical science program basic, pre clinical practices;
 - (c) Facilitating lecturers and researchers of the Parties for research and community service that is aligned with the vision and mission of the Parties;
 - (d) Providing experts as resource persons in studies, science and technology development of the Parties; and
 - (e) Any other areas of co-operation which may be mutually agreed upon by the Parties.





ARTICLE IV

EFFECT OF MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding serves only as a record of the Parties' intentions and does not constitute or create obligations under domestic or international law and will not give rise to any legal process and will not be deemed to constitute or create any legally binding or enforceable obligations, express or implied.

ARTICLE V

NO AGENCY

Nothing contained herein is to be construed so as to constitute a joint venture partnership or formal business organization of any kind between the Parties or so to constitute either Party as the agent of the other.

ARTICLE VI

ENTRY INTO EFFECT AND DURATION

1. This Memorandum of Understanding will come into effect on the date of signing and will remain in effect for a period of **FIVE (5)** years.

2. This Memorandum of Understanding may be extended for a further period as may be agreed in writing by the Parties.

ARTICLE VII

NOTICES
